<p>What is the overall deductible?</p>	<p>Network providers: \$1,000/individual, \$1,000/individual under family or \$2,000/family Out-of-network provider: \$2,000/individual, \$2,000/individual under family or \$4,000/family</p>	<p>Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. The deductible is Embedded. If you have other family members on the plan, each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible. Deductible year runs 01/01 – 12/31</p>
<p>Are there services covered before you meet your deductible?</p>	<p>Yes. Preventive care services are covered before you meet your deductible.</p>	<p>This plan covers some items and services even if you haven't yet met the deductible amount. Does this plan provide Minimum Essential Coverage? Yes

This is not a cost estimator. Treatments shown are just examples of how this [plan](#) might cover medical care. Peg is Having a Baby
(9 months of in-network pre-natal care and a hospital delivery)

(a year of routine in-network care of a well-controlled condition)

- Other [Coinsurance](#) 20%

This EXAMPLE event includes services like:

- Primary care physician office visits (*including disease education*)
- [Diagnostic test](#) (*blood work*)
- Prescription drugs
- [Durable medical equipment](#) (*glucose meter*)

Total Example Cost	\$5,600

In this example, Joe would pay:
